Application and use

The products are intended to be used for general purposes such as construction and equipment manufacturing, as well as for the transport of liquids and gases in pipe installations, equipment manufacturing, tank construction and petrochemicals.

Marking

The Kiwa®-mark products are marked with the word mark "KIWA". Place of the mark: outside of the pipe

Compulsory specifications:

- name or logo of the manufacturer;
- symbol to indicate the series (H or M) (see Table 2) or the type (L, L1 or L2) (see Annex B);
- symbol S (seamless) or W (welded), to indicate the pipe manufacturing process;
- cast number or a code number;

Marking shall be applied within 1m of each end of the pipe.

At the discretion of the manufacturer colour coding may be used as follows:

- Heavy: red;
- · Medium: blue;
- Types: according to Annex B. Color coding bands shall be approximately 50mm wide

Method of marking:

- Non-erasable;
- visible after assembly.
